10. THE GOVERNMENT REQUIRES PERFORMANCE OF THE WORK DESCRIBED IN THESE DOCUMENTS (Title, identifying no., date):

Sacramento River Erosion Control, Site 56.7 Left, River Mile 56.7 to 57.1, Sacramento River, Sacramento, Sacramento County, California (just downstream of Miller Park). This procurement is 100% set-aside for 8(a) firms serviced by either the SBA San Francisco District Office or the SBA Fresno District Office, and must possess a bona fide place of business within the territories of either of these two district offices. JOB DESCRIPTION: Bank protection, stabilization, and mitigation of 1600 lineal feet of levee along the left bank of the Sacramento River. All work is to be done from the waterside. The stabilization and bank protection part of the work involves clearing large and dense trees and vegetation, as well as breaking in place and moving large amounts of concrete rubble. Excess rebar and other metal will need to be removed as well. Approximately 65,000 tons of rock are to be placed over the cleared slope to stabilize the over steep levee slope and provide bank protection. The mitigation part of the job includes removing large (3+ feet dbh) trees removed from the site. 40 trees removed are to be saved and anchored back onto a rock berm built as part of the stabilization/bank protection part of the work. A 5-foot deep planting trench is also to be built into the rock berm. Th
